INSTRUCTIONS AND GENERAL INFORMATION

Instructions for Submitting Applications:

- 1. Complete and sign the attached application form. Use extra sheets for any responses, if needed.
- 2. The following **MUST** be submitted with the application:
 - a) A copy of high school transcripts listing **Grade Point Average (GPA)** and Class Ranking (MINIMUM 2.5 <u>CUMULATIVE</u> GPA). Note: *For those schools that do not have GPA*, please provide SAT Scores (MINIMUM of 900).
 - b) A copy of any undergraduate school transcripts listing Grade Point Average (GPA).
 - c) **Two letters** supporting the character, achievements, and potential for education and career advancement of the applicant. Letters may be from a school official (principal, counselor, teacher, etc.), a minister, coach, employer or any person with significant knowledge of the applicant.

General Information:

- 1. Applications and support documents must be received by <u>July 14, 2023</u>. No applications will be accepted by facsimile (fax) transmission. It is the responsibility of the applicant to submit the application form with appropriate transcript and letters as one complete package to the Scholarship Chairperson. Transcripts or letters mailed separately to the scholarship Chairperson are discouraged.
- 2 Scholarship awards will be made to residents of public and other assisted housing in the Little Ten service area who have maintained their residence for *six months prior to July 14, 2023*.
- 3. All applicants must graduate no later than *June 30*, *2023* or be a returning adult student. The scholarship grantees will be announced by August 31, 2023.
- 4. Applicants who have previously attended an institution of higher learning must not be on academic probation and must have maintained a minimum GPA of **2.5**.
- 5. Funds are to be utilized beginning with the Fall Semester 2023 school year.
- 6. Finalists and the grantees will be selected by the Scholarship Committee of the Association.
- 7. Scholarship funds will be forwarded to the school in installments of \$500 per semester if the student maintains a minimum of 2.5 <u>cumulative</u> GPA and completes enough credits to be a full-time student. In cases where the school reduces the student's financial aid by the amount of the scholarship, the funds will be forwarded to the PHA to be disbursed to the student or will be sent directly to the student. All awards must be fully utilized by the end of Spring semester 2025 unless an extension has been requested by January 31, 2025.

- 8. The recipient of the awards must attend an accredited university, college, vocational, technical, or business school. Letters of acceptance and academic schedule will be required prior to disbursement of funds.
- 9. Scholarship recipients will be required to forward a transcript at the end of each semester, to the Scholarship Chairperson or to the housing authority's Scholarship Committee representative.
- 10. If a scholarship recipient's family moves out of public or assisted housing after the award has been made, the recipient shall be eligible to continue to receive funding provided other guidelines are met.
